

# Privacy Policy

This privacy policy explains how we collect and use personal information in connection with the Tino Andersen International Guitar Festival (TAIGF), including the international competition, concerts, classes, and other related activities.

## **1. What We Collect**

We may collect and store the following information:

- Name, contact details, date of birth, and guardian contact (for minors)
- Bank account details (for prizes and honorariums)
- Photos, video, and audio recordings from festival activities
- Email addresses (for registration, updates, and newsletters)
- IP address and site usage data (via cookies)

## **2. Purpose of Data Collection**

Personal data is collected and used to:

- Administer the competition and festival events
- Organize travel and accommodation for participants and guests
- Process payments (e.g., prizes, fees, and honorariums)
- Communicate with artists, participants, guardians, and attendees
- Document and promote the festival through media
- Fulfill legal requirements (e.g., police background checks for staff working with minors)

## **3. Legal Basis for Processing**

Our data processing is based on:

- Consent (e.g., registration, use of images, newsletters)
- Contractual necessity (e.g., participation agreements)
- Legal obligations (e.g., background checks)
- Legitimate interests (e.g., event promotion and organization)

## **4. Sharing of Data**

We only share data when necessary and relevant:

- With travel agencies, hotels, and transport providers
- With media partners (photographers, videographers, streamers)
- With accountants or financial partners (for payments)
- With selected festival collaborators (only essential information)

## **5. Data Retention**

We retain data only as long as necessary:

- Registration information is deleted no later than [X] months after the event
- Media content (photo/video) may be retained for up to [X] years unless a removal request is made

## **6. Media Use**

Photos and video may be captured during the festival and used in promotional and documentary material.

- Parental consent is required for children under 15
- You may request removal of images or recordings at any time by emailing Contact@taigf.com

## **7. International Transfers**

Personal data may be transferred outside the EU/EEA if necessary, for example, when arranging international travel or sending payments abroad. We take appropriate steps to ensure secure handling.

## **8. Your Rights**

You have the right to:

- Access the personal data we hold about you
- Request correction or deletion of your data
- Withdraw consent at any time
- Object to processing
- File a complaint with the Norwegian Data Protection Authority ([www.datatilsynet.no](http://www.datatilsynet.no))
